"1BD 4-792-L CAREFUL SURVEY WILL BE MADE TO ASCERTAIN THAT ALL ENLISTED PERSONNEL LEAVING YOUR STATION FOR RETURN TO U.S. HAVE IN THEIR POSSESSION SPARE WEAPON AND PASS EQUIPMENT."

4. FR. PLAN: The following teletype received from 1st Bomb Division dated 19 August 1944:
"1BD 2-811-3 FOLLOWING MILITARY FROM HQ, EIGHTH AIR FORCE DATED 18 AUGUST 1944, IS ISSUED FOR YOUR INFORMATION AND GUIDANCE: QUOTE MIL PERS AND CIV PERS SERVING WITH US IN THIS AREA MUST BE PAID FROM UK OR FROM COUNTRY TO US OR TO UK IN ACCORDANCE WITH FR. PLAN. PAR 3, SER 1, MD DER 215, 1 JUN 44 WILL NOT BE APPLICABLE IN THIS THEATRE. IT OBLIGES TO REDUCE TO MINIMUM VAST AMOUNTS OF CURRENCY, CO'S UNDER YOUR JURISDICTION ARE DEPOSED TO CALL TO ATTN OF ALL CONCERNED FACT THAT FR. PLAN IS ENTERED AS PAYROLL OR PAY VOUCHER DEDUCTION, AND WILL TAKE SUCH STEPS AS MAY BE NECESSARY TO ENCOURAGE EMPLOYMENT OF THIS METHOD. DOCLINTHE UNQUOTE."
