"EFFECTIVE IMMEDIATELY, ALL UNIT HISTORIANS IN OPERATIONAL SQUADRONS OF FIRST BOMBARDMENT DIVISION WILL PROCURE ONE COPY OF THE LOADING LIST PREPARED FOR EACH MISSION BY SQUADRON OPERATIONS. TO REDUCE THE AMOUNT OF WORK REQUIRED TO ACCOMPLISH THIS, IT IS SUGGESTED THAT EACH UNIT HISTORIAN MAKE ARRANGEMENTS WITH ONE OF THOSE A'READY ON THE DISTRIBUTION LIST TO SAVE THE COPY HE RECEIVES FOR THE HISTORIAN. THESE LOADING LISTS WILL BE ATTACHED TO THE MONTHLY HISTORY AND FORWARDED TO THIS HEADQUARTERS WITH THE UNIT HISTORY BY THE 14TH DAY OF THE FOLLOWING MONTH.

4. ELECTRICAL INSTALLATIONS IN BUILDINGS: The following is quoted from Air Ministry Order A.468 - Electrical Installations in Buildings:

"A recent accident at another station which involved an outbreak of fire and the death of a N.C.O. by electric shock was found, on inquiry, to have resulted from the fitting of unauthorized apparatus to the lighting circuit of a barracks hut.

Attention is therefor drawn to Air Ministry Order A.236/42. as amended, which is republished below and which is to be strictly observed:

With reference to Air Publication 830 Vol. 1, Chapter 31, paragraphs 55 and 56, C.O.'s are reminded that Directorate of Works type electrical installations drawings for a building constitute the approved scale. Accordingly, prior approval of the Superintending Engineer concerned must be sought for any extension to an existing system, e.g. provision of a power point, increase in lamp wattage, etc.

The above ruling applies equally to extensions which it is proposed should be carried out on a repayment basis and which will be connected to a non-entitled circuit.

In view of the limited supplies of electrical materials and the limited installation labour available, C.O.s are to restrict their requests for extensions to existing systems to the minimum!"

Site Commanders will check all living huts for unauthorized wiring -i.e., wiring cut into main power lines -- and have such wiring removed at once.
